GENERAL CONDITIONS OF THIS FORM

First. - Organization

The organization of FEINDEF 2023 corresponds to FEINDEF FOUNDATION with address at Paseo de las Delicias, 20 7th Floor 28045 Madrid and N.I.F. G-01965441.

FEINDEF FOUNDATION designates GRUPO METALIA as the entity in charge of providing the necessary support services for the planning and material execution of the FEINDEF 2023 event.

Second. - Object of the contract

The purpose of this contract is to be an Exhibitor at the FEINDEF 2023 event to be held at Feria de Madrid (IFEMA) - Halls 8 and 10, on May 17th, 18th, and 19th, 2023. From 9:30 a.m. to 6:00 p.m.

This contract will enter into force upon its formalization and will last until the end of the event.

The basic services included for the exhibitor are space rental, mandatory insurance (Civil Liability and Damage Insurance), exhibitor passes and invitations, a parking space and presence in promotional elements of the Fair. These services may be extended in accordance with the conditions established in the document GENERAL CONDITIONS FOR PARTICIPATING IN FEINDEF 2023 depending on the type of participation.

Third. - Amount and Form of Payment

3.1.- The Exhibitor will pay to FEINDEF FOUNDATION the amount established according to the chosen modality.

Payment will be made by bank transfer to the name of FEINDEF FOUNDATION to the account ES42 0049 5115 3226 1627 0453, sending proof of deposit or transfer.

1st Payment: 40% + 10% VAT within 30 days of your confirmation as an exhibitor at FEINDEF 2023 and receipt of the corresponding invoice.

2nd Payment: 60% + 10% VAT up to 90 days before the start of the assembly of the Fair. Maximum February 13rd, 2023.

3.2.- According to current legislation on Value Added Tax, non-Spanish non-Community and intra-Community companies registered in the ROI (Registry of Community Operators), embassies, consulates, and international organizations recognized by Spain are exempt from VAT.

Fourth. - Failure to comply with deadlines

In the event that the aforementioned payments are not made within the established deadlines, the Exhibitor will lose all rights to the reserved spaces, as well as the amounts delivered, and the Organizer may assign the reserved spaces to other companies or dispose of them for own use.

Fifth. - Installation and decoration of stands

No decorative element and/or signage may protrude from the perimeter of the stand.

The Exhibitor is obliged to respect the current provisions related to the decoration and assembly of his stand that have been indicated by the Organization. The elimination or substitution, by the exhibitor, of some training element of the stand does not imply a reduction in cost.

All the material used, both structural and electrical, is rented and any deterioration will be billed according to the rate.

Additionally, any exhibitor can contract services that appear in the IFEMA Services Catalogue, which will be sent to the firm.

The exhibiting company must provide all the graphic material necessary for the design and realization of the stand. This material will be delivered to the Organization 3 months before the event is held.

Sixth. - Allocation of Spaces

The allocation of spaces will be the exclusive responsibility of the Event Organizer. In the allocation of spaces, it will take into account, as far as possible, the sectorization of the event, as well as the date of request, harmony between spaces and any other circumstance that affects the improvement of the event. The Organizer reserves the right to modify the location if exceptional circumstances so require, without the Exhibitor being entitled to compensation. In this case, it will try to allocate a space that has similar characteristics to the one initially assigned.

Seventh. - Obligations of the Exhibitor

7.1.- Payment of amounts on time: In the event of not paying within the established deadlines, the Exhibitor will lose all rights to the reserved space, making said space available to the Organizer, which may offer it to other companies. In any case, the occupation of exhibition space will not be authorized until it has been paid in full along with the services.

7.2.- Prohibition of dangerous activities: Those activities that pose a risk of accident are prohibited in all areas of the Fairgrounds. Both in relation to the exhibits and the stand assembly and decoration elements, all those Occupational Risk Prevention Regulations that are applicable to their transport, assembly, handling, operation and disassembly will be complied with.

7.3.- Transfer Prohibition: The partial or total transfer of the rights as an Exhibitor to third parties, which may exclusively be the companies that sign and seal this document, is not permitted (except with the prior authorization of the Organizer).

Failure by the Exhibitor to comply with the obligations set forth in this point will determine the loss of the rights over the assigned or unoccupied space, passing said space to the disposal of the Organizer, which may offer it to other applicants, without, in under no circumstances will the Exhibitor have the right to any type of compensation or refund of any amount.

Eighth. - Waiver

The tacit or express waiver of the Exhibitor to his participation in the celebration of FEINDEF 2023 is reason for loss of the amounts paid. If the waiver takes place in the sixty days prior to the opening of the Event, full payment of the space may be required, even when it may be later occupied by another Exhibitor.

Ninth. - Applicable regulations

9.1.- The Exhibitor must comply with all the regulations applicable to participation in FEINDEF 2023 specified in point 2 of the document GENERAL CONDITIONS FOR PARTICIPATING IN FEINDEF 2023 that has been sent along with this form.

The exhibitor will especially ensure compliance with the IFEMA Safety regulations and those legally applicable in accordance with state, regional and local legislation, including the current Law on Occupational Risks and its implementing regulations. In relation to IFEMA's Specific General Participation Regulations, these are reflected in the document Annex to this contract, being mandatory.

9.2.- The Exhibitor knows and accepts the specific IFEMA General Participation Regulations for Exhibitors, which is attached as an annex to this contract.

9.3.- On Data Protection: in accordance with the provisions of current regulations: Organic Law 3/2018, of December 5th, on the Protection of Personal Data and guarantee of digital rights, which adapts the Spanish data protection regulations a Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27th, 2016, FEINDEF FOUNDATION informs of the collection and processing of personal data whose purpose is to be able to attend to any type of management related to the Exhibitor. The data will not be transferred to third parties, except by legal obligation or when the provision of a service implies the need for a contractual relationship with a treatment manager.

Every Exhibitor has the right to access, rectify or delete erroneous data, request the limitation of the processing of their data, as well as oppose or withdraw consent at any time. Tenth. - Exhibitor services offered by IFEMA

Following current regulations, FEINDEF FOUNDATION informs its exhibitors of the transfer of their data to IFEMA for the sending of the Catalogue of Services that it markets for the event.

In the event of requesting the provision of any service, the data provided by the Exhibitor will be included in an IFEMA file for the purpose of managing the provision thereof. IFEMA may use this data to carry out periodic communications, including by electronic means, to report on trade fair activity - activities, content and services - as well as to communicate them, with an obligation of confidentiality, to the companies that collaborate with IFEMA in its execution, exclusively for the purpose of that they send you information

about them and attend to your orders. The rights of access, rectification, opposition and cancellation of this data may be exercised by means of a letter addressed to IFEMA: Data Protection, post office box 67.067 (28080) of Madrid, or via e-mail to the address: protecciondatos@ifema.es.

Among the services offered exclusively by IFEMA and which must be contracted directly with them are services such as: Compressed air, water connections, Internet wi-fi, stand cleaning, etc... Well in advance of the event, the Organization will provide you with a URL prepared by IFEMA with the services and rates that they offer exclusively.

The deadline to proceed with the contracting of the services mentioned in the previous paragraph, THIRTY (30) days before the start date of the assembly. IFEMA reserves the right to reject requests for services requested after this date.

In the event of accepting the provision of requested services within the FIFTEEN (15) days prior to the start of the assembly, during the assembly or the holding of the Fair, IFEMA will apply a 25% surcharge on the established rate.

A service may be canceled within FIFTEEN (15) days prior to the start of assembly or during assembly with payment of 40% of the corresponding fee. In the event that a service already provided is cancelled, 100% of its cost must be paid.

IFEMA will establish a merchandise entry control to allow entry only to those exhibitors who have previously paid for the services requested through the IFEMA service catalogue.

Eleventh. - Change of dates or temporary suspension due to force majeure

If for reasons of force majeure, unrelated to the organization, the celebration of the fair had to be postponed to other dates within the 2023 financial year, 50% of the amount of the stand will be refunded. The exhibitor in no case loses the 50% withheld since his stand will continue to be reserved and the amounts withheld will count for the holding of the event on the new date. If the postponement caused the celebration of the fair to be delayed to 2024, 70% of the amount of the stand will be refunded. The exhibitor in no case loses the 30% withheld since his stand will continue to be reserved and the amounts withheld will count for the holding of the event on the new date.

Twelfth. - Permissions and licences

The Exhibitor must have the legally required licenses or permits for the possession, display or use of any type of goods to be exhibited in the assigned space, as well as deliver in a timely manner the documentation required by the Organization in the cases of exposition of Real Weapons or Defence Material or real size dummies.

The Exhibitor authorizes the total or partial reproduction of the exhibited products that, eventually, the FEINDEF FOUNDATION may need and/or reproduce in its promotional material.

Fourteenth. - Assembly and disassembly

The Exhibitor is obliged to respect all current provisions related to the prevention of accidents and fires.

For free design stands:

- **Assembly:** from Saturday, May 13th to Tuesday, May 16th, 2023 from 8:30 a.m. to 9:30 p.m.

- **Disassembly:** Friday, May 19th, 2023 from 3:30 p.m. to 9:30 p.m. (only removal of small items). Saturday, May 20th, 2023 from 8:30 a.m. to 9:30 p.m. and Sunday, May 21st, 2023 from 8:30 a.m. to 3:30 p.m.

In the case of free-design stands, the exhibitor may request a budget from the Organizer to extend the assembly schedule, upon acceptance of which they will receive the corresponding invoice. This extension will only be effective after sending proof of payment of that invoice 60 days before the start of the assembly of the Fair.

For modular stands:

- **Assembly:** Tuesday, May 16th, 2023 from 12:30 p.m. to 9:30 p.m.

- **Disassembly:** Friday, May 19th, 2023 from 3:30 p.m. to 9:30 p.m. Saturday, May 20th, 2023 from 8:30 a.m. to 9:30 p.m. and Sunday, May 21st, 2023 from 8:30 a.m. to 3:30 p.m.

The access of assemblers or participants will not be allowed, nor will assembly work or preparation of

the stands be carried out outside the days and times indicated.

The occupation of the space will not be authorized nor will the stand be delivered to the exhibitor who has not fully paid the contracted space and the expenses of the requested services.

Exhibitors will be able to access their stands from 8:30 a.m. and leave them from the end of the fair until 7:00 p.m.

The Exhibitor is obliged to attend and remain with the products exhibited at his stand during the entire period of operation of the fair. Failure to comply with this regulation could mean the loss of the preferential renewal right of the space.

After the period established for the dismantling of the stand, all the materials that still remain in the pavilion will be removed by IFEMA. The Exhibitor loses any right to claim for losses or damages on these materials and the Exhibitor will pay the expenses of the removal, it will be billed by IFEMA according to its official rates.

Fifteenth. - Jurisdiction

This form, once your request is formalized and becomes binding, together with the document GENERAL CONDITIONS FOR PARTICIPATING IN FEINDEF 2023,

constitute your participation contract in FEINDEF 2023. This contract is private. For all questions that arise in the interpretation and application of the same, the parties submit to the jurisdiction of the competent Judges and Courts of Madrid, expressly waiving any other jurisdiction that may correspond to them.
